	<p>RESOLUTION: The clerk will write to Mr Troughton and advise Herefordshire Council of the vacancy arisen.</p> <p>b) To decide on Locations for new Notice Boards for each parish</p> <p>Communication with residents has improved with the implementation of a website but currently only a notice board in Streeton Grandison is used.</p> <p>RESOLUTION: It was agreed that notice boards in all parishes need to be used more and articles placed in local newsletters promoting the website, meeting dates and list of councillors.</p> <p>c) To Discuss General Power of Competence</p> <p>The councillors had been sent details of this prior to the meeting. The GPC (LA 2011 s1(1)) gives local authorities, including eligible local councils, “the power to do anything that individuals generally may do” as long as they don’t break other laws. It is a ‘power of first resort’; this means that when searching for a power to act, the first question you ask is whether you can use the GPC.
