

# Residents' survey Feb 2017

- Questionnaires hand delivered
- 119 forms collected 31.6% of 16 and over
- Older people and females over-represented, and 24% of respondents from one postcode (HR8 2TD)
- 26 open and multiple choice questions about 14 policy options: for the vision/objectives, housing, environment, economy, flooding and other issues
- Focus tonight on answers to the multiple choice questions


## Vision and objectives



#### Agree with the objectives?


- Housing 92%

### Policy option 1: settlement boundaries




- Majority support for the draft boundaries
- Notable number of comments and suggestions for further review

# Policy option 2: site allocations in all or only some of the villages?




- 47% supported seeking sites in all villages
- Lower Eggleton and Fromes Hill main focus villages
- Less interest in the lower-tier LPCS settlements

# Policy option 2: first choice of settlement for development




- Significant non-response (51%)
- Lower Eggleton and Fromes Hill favoured for their main road location
- Other villages felt to already have enough/too many houses

## Policy option 3: Housing numbers




- Support for up to 10 houses in total in villages
- Less for up to 20 homes—highest 'no' score at 50%

# Policy option 4: size of each housing development




- Little support for one large estate 72% opposed
- Individual dwellings most favoured only 7% against
- Smaller schemes: for 56%, against 24%



#### Q14: protecting the environment

- Most important, to 76%: protect the natural environment
- Followed by protecting views and vistas (62%)
- Least important: conserving historic buildings and features (59% saw this as most important)

#### Q15: dark skies

Important to 71%

#### Policy option 7: Local Green Spaces

#### Q17: areas for protection as LGS

- Homend Park (by 54% of respondents): historic value, recreational value, biodiversity, visual amenity
- Other areas: e.g. Canon Frome Court, Stretton
   Grandison church and environs, Hfds and Glos. canal

### Policy option 8: built heritage

#### Q18: distinctive local built features

- Specific buildings: Canon Frome Court and Church, Church Farm, Stretton Grandison church and neighbouring houses
- Building types: hop kilns, converted barns, rural look and feel
- Materials: brick, stone, timber, slate, thatch.

# Policy option 9: re-use of redundant farm buildings

#### Q19: policy criteria to guide re-use?


- Preferred uses: small-scale offices/business units, workshops, live/work units and others, including housing.
- Planning criteria:
  - safe access and visibility, traffic and parking
  - avoid adverse impacts on amenity
  - refurbishment in scale and keeping.


# Q20: policy criteria to guide new agricultural developments?




#### Policy option 11: type of energy scheme




- Solar power most favoured, by 66%






- Priority issue, for 76% attracting younger people

- Develop environment policies to reflect responses and comments made
- Review comments on LGS at Homend Park against NPPF criteria
- Good feedback on criteria for re-use of rural buildings, and for new agricultural buildings at Homend Park
- Reflect responses to Q25 sustainable community in policies for housing and employment, as far as possible
