8. Highways

8.1 To consider an update on the installation of traffic calming measures through Stretton Grandison

The clerk REPORTED that almost all costs had now been received. Once she had them all she would be able to submit the grant application to the Police and Crime Commissioner for consideration.

8.2 To consider the cost of the SID Assessment Request Fee £565 + VAT = £678

8.3 To consider signing the Structure Licence to allow White Gates to be installed by the highway

The Structure Licence was SIGNED to allow the white gates at either end of Stretton Grandison to be erected.

8.4 To consider the TRO consultation on A4103 - Western Side of Fromes Hill.

The clerk REPORTED that this involved moving the 40mph sign westwards past the C1158. It was RESOLVED that the clerk could respond giving Parish Council support for this alteration if the consultation document arrived between meetings.

The clerk REPORTED that the documents were being prepared for consultation on the speed limit alteration on this section of the highway. It was RESOLVED that the clerk could respond giving Parish Council support for this alteration if the consultation document arrived between meetings.
