Minutes of the Meeting of the Parish Council held online via Zoom due to the Coronavirus on Monday 8th March 2021 at 7.30pm

1. To Accept any Apologies for Absence and Note the Reason

Apologies were RECEIVED and ACCEPTED from Cllr Ed Godsall.

2. To Record any Declarations of Interest and Consider any Requests for Dispensations

None

To Consider Approval of Minutes of Parish Council meetings held Monday 11th January 2021
 The Minutes were APPROVED and duly signed by the Chair.

4. Public Participation Session for Local Residents to raise matters relevant to the Parish Council

The following items were RAISED:

- Was anyone else at Canon Frome having difficulties with broadband? Fastershire's contact details were given.
- Thanks were expressed to the clerk and Council for all their efforts with the highway measures.
- Concern was raised over the large tump of chicken manure in Stretton Grandison. Is it leaching into the rivers?
- What was the legality of having a bonfire in a built-up area?

Cllr Malcolm Davies and Ward Cllr Jonathan Lester joined the meeting.

5. To receive a brief report from Three Crosses Ward Councillor Jonathan Lester

Cllr Lester's report included the following items:

- The bypass transport packages have been cancelled.
- Council tax is set to rise by 4.99%
- Issues with the River Lugg is having a knock-on effect on NDP's
- Planning:

c) To consider The Farm, Bosbury, Woodland Management Consultation

It was RESOLVED to thank the agent for such a comprehensive report. It was queried whether they would consider an expansion of the woodland area using trees provided by volunteers and working with local schools?

d) To consider the NDP following recent information regarding the Basic Condition Statement and HRA.

The clerk REPORTED that she had received information from Herefordshire Council NDP Team. This stated that the NDP, whilst having to go ahead to referendum stage, could not be formally "made" as it no longer met the Basic Condition statement due to the raised phosphate and nitrate levels in the River Lugg Catchment Area. The plan would continue to carry significant weight, and once the issue is resolved would go on to be "made". Timescales are at present unknown but Herefordshire Council NDP Team are working hard to resolve this. It was AGREED that an extra-ordinary meeting was needed to decide whether to put out a leaflet advertising the referendum to parishioners.

7. Highways/Footpaths:

 To receive an update on the installation of traffic calming measures through Stretton Grandison and consider next steps.

The clerk REPORTED that she is waiting on a date for installation. The SID's have been delivered and are ready to be installed.

b) To consider the need for speed reduction and double white lines between Lower Eggleton and Fromes Hill
It was REPORTED by Mr. Stephens that there have been several serious accidents along this stretch of highway. It was
AGREED that the clerk should submit two Traffic Regulation Order assessments. The first for the installation of double
white lines to prevent overtaking at dangerous points. The second to request a speed reduction from 60mph to 50mph
over this stretch. It was AGREED that the clerk would liaise with Mr. Stephens and then approval of the TRO submissions
could be done via email between meetings.

c) To note the update on the Traffic Regulation Order at Fromes Hill

It was NOTED that the traffic surveys – postponed due to the pandemic – will now be undertaken. It was further NOTED that a speed limit reduction from 40mph to 30mph is being considered.

8. Finance:

a) To Consider the March finance report and bank statements. - Appendix 1

The clerk REPORTED that finances appeared overspent although this was not the case as grant monies had been received to offset expenditure. The following budget areas have minor overspends against them: Insurance and elections. Elections will come out of the reserves set aside for election costs. The Highway measures and NDP budget areas are largely covered by grant money. The report was APPROVED as evidence of budget monitoring and bank reconciliation.

b) To Receive Update on Poorlands Meadow Trust

It was REPORTED that banks were still hard to access under the current lockdown. It was AGREED to discuss moving to Unity Bank Ltd at the May meeting and the possibility of opening a Poorland account with them too.
